# CAN COLLABORATIVE DESIGN IMPROVE WATERFRONT PUBLIC SPACES AND MOBILITY AND CATALYZE ECONOMIC DEVELOPMENT?

reSITE Conference takes aim at that question. This major international conference will take place at the National Gallery - Veletržní palace. The conference will have discussions and targeted lectures from international and local experts in four fields: Design, Private Development and Finance, Municipality Leadership, and Public Advocacy / Community NGO's. All discussions will focus on waterfront, urban mobility and public space design in cities. The discussions will seek to bridge the gap between designers, private developers, policy makers and the public.

National Gallery - Veletržní palac Prague, Czech Republic 24 - 27 MAY 2012

reSITE is the platform to exchange ideas about making cities more livable. reSITE is operating under the Auspices of the City of Prague and the US Embassy in Prague.

#### HONORARY KEYNOTE ADDRESS: JANETTE SADIK-KHAN

Janette Sadik-Khan is the current Commissioner of the New York City Department of Transportation, appointed by New York City Mayor Michael Bloomberg in 2007. Sadik-Khan has been a key player in Mayor Michael Bloomberg's efforts to transform New York into a green city under PlaNYC by reducing the city's carbon footprint 30% by the year 2030.

Beginning with Sustainable Streets, DOT's first strategic plan published in 2008, Commissioner Sadik-Khan has implemented a series of innovative projects: the creation of Broadway Boulevard and the pedestrianization of Times Square, new Select Bus Service Routes in the Bronx and Manhattan, the installation of 18 plazas, the addition of over 250 miles of on-street bike lanes, car-free summer streets, weekend pedestrian walks and a new Street Design Manual requiring higher quality street designs for New York City.

Commissioner Sadik-Khan is President of the National Association of City Transportation Officials (NACTO), Chair of the Transportation Research Board's (TRB) Committee on Transportation Issues in Major U.S. Cities, and was appointed to the Energy Secretary's Energy Efficiency and Renewable Energy Advisory Committee (ERAC). She has published widely on transportation policy, planning, and finance and project management. She holds a B.A. in Political Science from Occidental College, and a law degree from Columbia University School of Law.

#### KEYNOTE ADDRESS: TOMÁŠ SEDLÁČEK\* / NERV

Tomáš Sedláček is one of 15 members of NERV, the advisory body to the Prime Minister of the Czech Republic set up in 2009 to tackle financial crises and to assist with the rotating presidency of the EU. Sedlacek co-designed a macroeconomic package which became a vital inspiration for economic policy of the current and previous Czech governments. As CHIEF ECONOMIC STRATEGIST OF CSOB BANK, Sedlacek is a specialist on fiscal policy, euro and European affairs in the leading Czech bank CSOB, a unit of multinational financial group KBC. He is a regular weekly columnist of the top Czech business newspaper Hospodarske noviny since 2006, frequent commentator of public affairs and frequent pannelist with over three hundred speaches since 2009.

#### **SESSION 1: COMMUNITY FORUM**

Moderator: Igor Kovačevič / Director, Centre for Central European Architecture / Prague

The discussion asks how community groups can participate in the planning and design process. Is their role to be urban activists? Or, is there a larger mission? How do we move from activism to action? Who bridges the gap between their democratic ideals of public space and action on the part of municipalities, architects and developers? How can community groups infiltrate the complex world of planning politics and what is their outlook for the future?

#### **SESSION 2: ECONOMICS OF DEVELOPMENT**

Moderator: Ira Saul Rubenstein / Founding Chairman, Czech Green Building Council

The collapse of Lehman Brothers in 2008 changed the game for real estate developers and financiers. Now, who pays for public amenities: developers, taxpayers, both? The discussion will start with brief presentations from financiers of major urban projects then transition to a discussion about the new game and how developers are moving forward with quality design and public amenities in mind. In order to compete globally, cities need to be competitive. In order to be competitive they need to be livable. How can creative financing and public / private partnerships improve livability in cities?

#### KEYNOTE ADDRESS: REINIER DE GRAAF / OMA, AMO / ROTTERDAM

Reinier de Graaf (born Netherlands, 1964) is architect and Partner of architecture and design office OMA, founded by Rem Koolhaas, with offices in Rotterdam, New York, Beijing and Hong Kong and projects in over 30 countries worldwide. As Partner of OMA he is responsible for a number of building projects in Europe, Russia, and the Middle East. De Graaf also supervises the work of AMO, a counterpart to OMA, which operates in fields such as media, sociology, technology, energy, fashion, publishing and graphic design.

#### WATERFRONT PLANNING IN EUROPE

What are other cities in Europe doing with their under utilized waterfronts? Lisa Deidrich is an expert in European contemporary landscape architecture will give a lecture titled "In Motion - Landscape Architecture Europe" that will focus specifically on waterfronts. Michael Rink will talk about planning for Hafen City in the City of Hamburg under Jörn Walter, the well-known Director of Urban Planning in Hamburg.

#### PRAGUE TRANSFER

Moderator: Lisa Diedrich / Editor-in-Chief, 'scape magazine / Munich

This discussion will focus on the framework that both enables and stifles creative design for public space in both countries. What are potential points for Czech designers to build upon? Can models employed in German cities be a point of reference for Czech cities? Can initiatives like IBA in Hamburg be points of reference for Czech designers and the general public to increase awareness about quality design? The broad mission of the discussion is to exchange knowledge between German and Czech participants

#### KEYNOTE ADDRESS: JAN GEHL / GEHL ARCHITECTS / COPENHAGEN

Jan Gehl is a Danish architect and urban design consultant based in Copenhagen whose career has focused on improving the quality of urban life by re-orienting city design towards the pedestrian and cyclist. He is a founding partner of Gehl Architects, urban research and design consultancy. Gehl started to explore the field of human-centered architecture together with his wife, who is psychologist. They set out to study the borderland between sociology, psychology, architecture, and planning in order to bring the human needs to the foreground of planning. Jan Gehl is an Architect MAA & FRIBA, Professor Emeritus of Urban Design at the School of Architecture in Copenhagen.
